

#### Water Well Driller Project

- Review of project
- Program Inactivation in 2011
- Industry Needs Analysis Developed for Water Well Drillers' trade
- ITA Standards Review Committee approve Reactivation





#### New certifications

- BCGWA contact ITA in Spring 2013
- Canadian Groundwater Association declared bankruptcy in March 2013
- This left a gap in access to certification to support licensing in the following areas:
  - Geotechnical/Environmental Driller
  - Geoexchange Driller
  - Well Pump Installer



### Industry Needs Analysis

- Summary of industry research undertaken to:
- Identify training-related problems in an industry
- Determine industry needs and priorities
- Recommend solutions
- Demonstrate stakeholder support for solutions





#### Link to the Ministry of Environment

 ITA, the Drilling Industry and the Ministry of Environment (MoE) have worked collaboratively since the initiation of this project

 New Ground Water Protection Regulation (GWPR) Act in BC, 2014

 Structure of ITA Certification needs to support the MoE in linkage to the new regulations





### **Routes to Certification**

- Certificate of Qualification
- a) Apprenticeship pathway only available for Water
  Well Driller technical training available in Alberta for
  this trade (not accessible in BC)
- b) Challenge pathway available in all Drilling trades





# Challenge Pathway

#### Who is Eligible to Challenge?

- Eligibility is based on a combination of hours and scope of trade.
- Each trade has its own individual requirements which will be listed on our website <u>www.itabc.ca</u>

• There are no exceptions to the Challenge requirements or the Challenge Application package.



#### **Declarations of Work Experience**

Will state that you have completed the hour requirements and demonstrated at least 70% of the competencies required.

#### **Employer Declaration**

- To be completed and signed by your direct supervisor.
- Form must be completed to include the company name, contact information, and company address.
- Are not to be completed by HR, payroll, or anyone else who did not directly supervise your work.

#### **Statutory Declaration**

- To be completed if you are selfemployed.
- Must provide the company name, contact information, and address
- Will require 3 specific references that can consist of:
  - 1 supplier
    1 employee
    1 Client
    multiple contractors

# Applying to Challenge

- Complete application package on our website on the specific trade page <u>www.itabc.ca</u>.
- Complete application will include:

Challenge Application Form Employer Declaration and/or Statutory Declaration \$120 Application Fee <u>http://www.itabc.ca/exams/fees-and-payment</u>

- All forms and documents must be completed in English.
- Challenge Application must be submitted as a complete package and can be submitted by email <u>customerservice@itabc.ca</u> or by fax at 778-328-8701 or by mail.



### Once your Application is Received

- Assessment process can take up to 6-8 weeks
- All references provided will be contacted by an ITA approved verifier by phone or email
- If approved, we will notify the applicant by email and the applicant will then be able to be scheduled to write the Interprovincial Red Seal exam or the Certificate of Qualification exam to be certified.
- If not approved, ITA will provide feedback as to why an applicant was not approved.



#### Timelines

#### Exam scheduling

- Exam scheduling depends on where in BC the challenger is writing. Examples:
- Vancouver 1 session a week(usually booked up about a month in advance)
- Victoria twice a month

Terrace - no organized sitting - the exam is sent to the local Service BC office and they will have 40 days to write the exam in Terrace.





## How long until I get my results?

- A challenger will get their exam mark 10 business days after they write the exam
- ITA certificates will be sent out on the next certificate run (Tuesday or Thursday every week).
- When the certificates are mailed out they are then into the postal system so we can't give an exact date when candidates will be holding their certificates.
- If you have not yet sent your application to ITA it is unlikely you will be certified before January 2016





### Writing the Exam

- Challenger will have 1 year from the date of approval to write and pass the exam
- Contact customer service to request exam date
- The written exam is multiple choice and the challenge must get at least 70% to pass the exam
- The exam can be written multiple times during the 1-year approval period; however, it may be required to submit proof of upgrading and re-write fees as applicable





### **Exam Accommodations**

- If English is your second language then you have the option to request a translator or a translation dictionary
- Challenger will need to arrange for own translator and pay for all costs associated with it.
